

**How your current District 1, District 2 and District 3 Representatives
Voted on bills Republicans supported**

HB 687- relative to extreme risk protection

This bill would allow for a mere accusation to cause a warrant to be signed for the seizure of firearms. Even if the person is deemed not to be a risk, they would still be forced to go to court in order to get their property back.

HB 731- establishing a state minimum wage and providing for adjustments to the minimum wage

This bill increased the minimum wage by 106% forcing our state's businesses to pay an unsustainable wage. This action would have a profound negative impact on New Hampshire's small and medium size business community

HB 559- relative to point of sale bags

This bill would require NH consumers ten to fifty cents per single use plastic bag. When the pandemic hit, the Governor instituted an emergency order banning the use of reusable bags.

HB 1700- relative to licensure of nonresident aliens temporarily residing in New Hampshire

This bill would issue nonresident alien driver's licenses that are identical to those issued to permanent residents. There is already a provision in law that covers driver licenses for nonresident aliens.

HB 1218-relative to net energy metering limits for customer generators and the purchase of output of limited electrical energy producers

This bill raises the net metering limit from 1MW to 5MW, and sets the cost of the surplus electricity at the default service rate. This forces utility companies to pay higher costs, which is then transferred to the rate payer.

HB 1101- imposing a waiting period between the purchase and delivery of a firearm

This bill imposed a three day waiting period between purchase and delivery of a firearm.

HB 1379 – requiring a background check for commercial firearms sales

This bill would require all firearms sales in NH to be processed through a licensed firearms dealer, who will conduct a background check.

HB 1699- relative to a tax on electronic cigarettes

This bill increases the tax on electronic cigarettes to 40% of the wholesale price

HB 1472- restricting the distribution of plastic straws

This bill prohibits distribution of plastic straws unless the customer requests one

HB 1564- prohibiting the use of polystyrene foam

This bill prohibits the use of polystyrene foam product in food service establishments

HB HB 1350- requiring a locking safety device be provided for commercial firearms sales and transfers

This bill requires all firearms sales to be accompanied by a locking device.

HB 1608-prohibiting the manufacture, sale, transfer, and possession of large capacity ammunition feeding devices.

This bill would prohibit ammunition magazines of more than 10 rounds for a long gun or 15 rounds for a hand gun

HB 1675-FN-relative to the right of any infant born alive to medically appropriate and reasonable care and treatment

This bill established the born alive infant act. The motion was inexpedient to legislate

HB 1285-relative to possession of firearms on school property

This bill prohibits the possession of a firearm on any school property

HB 1279-relative to the terms resident, inhabitant, residence and residency

This bill redefines the terms and restores language that was removed from the law in 2018

Buco not voting excused, Woodcock not voting not excused, Burroughs yea, Knirk yea, Ticehurst yea

HB 1653-FN-relative to domicile, residency, voter registration, and investigation of voter verification letters

This bill modifies the definition of domicile for voting purposes, modifies forms and procedures for voter registration, and removes the requirement that the secretary of state conduct post-election voter registration inquiries

HB 1143-repealing limited liability for manufacturers, distributors, dealers, or importers of firearms or ammunition

This bill repeals limited liability that is currently in New Hampshire law.

HB 1160-allowing municipalities to collect an occupancy fee from operators of local room rentals

This bill allows municipalities to collect an occupancy fee of up to \$2 dollars this is on top of the current rooms and meals tax of 9%. The money could be used by the municipalities for a capital fund, a revolving fund or a tourism support fund.

HB 1444-requiring the adoption of innovative vehicle emissions standards pursuant to section 177 of the federal Clean Air Act.

This bill requires the adoption of California Low Emission/Zero Emission vehicle standards to protect public health, enable NH automotive customers to utilize the extended emissions-specific warranty, and to enable NH automotive dealers to carry Zero Emissions Vehicles in stock.
